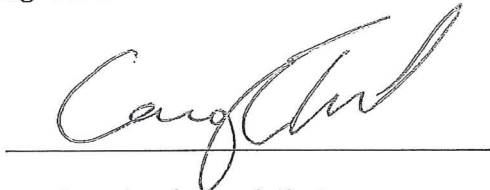

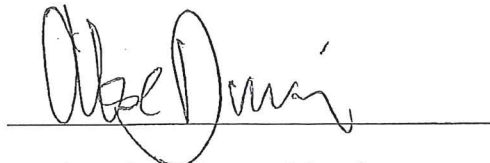

School Profile

Dickson College is committed to providing a supportive, innovative and educationally enriched learning environment for all students. At the core of our ethos is the notion that we will work together to develop informed, caring, creative and confident global citizens. This ethos is underpinned by the core values of excellence, opportunity and community, and we see our role as supporting the learning of each and every student, so that they can achieve their best, every day.

In 2015 the school completed a summative self-evaluation using our previous school plans, targets and the National School Improvement Tool (NSIT). The views of staff, students and parents were gained through staff meetings, forums, emails, and student meetings. This assisted in the development of a School Summative Report which was presented to an external validation panel.

The external panel reviewed our findings against the NSIT and also spoke with staff, parents and students prior to providing the school with an External Validation Report. This report is on our website. The recommendations from the report provided the basis for the development of this Strategic Plan that was developed in consultation with the school community and staff.

Strategic Priority 1: Enhance educational outcomes for all students

Outcomes to be achieved:

- Continued growth in educational outcomes for all students
- Evidence informed measures for capturing and improving student outcomes
- A functional contemporary learning environment that supports learning
- Innovations in learning and student engagement are established

Targets

By the end of 2020 the college will achieve:

- an ACT Senior Secondary Certificate or Vocational Qualification completion rate of 95% (91.5% in 2015)
- an ACT Senior Secondary Certificate or Vocational Qualification completion rate of 75% for Aboriginal and Torres Strait Islander students (62.5% in 2015)
- a school-wide system of collecting and analysing evidence that provides greater understanding and visibility of student performance by teachers and students
- a school-wide system for supporting ongoing innovation at the college

Targets

By the end of 2020 the college will achieve:

- An increase in student retention by 3% between Year 11 and 12 (Currently 90%)
- A reduction in V grades by 3% (currently 13%)
- a systematic approach to collecting and analysing data relating student wellbeing and the most vulnerable young people enrolled at our school
